1 Introduction

The YOSEIKAN BUDO springs from the idea of a synthesis of martial arts to realize an educational vision. This task has been entrusted to Hiroo Mochizuki since his earliest youth by his father Minoru - Minoru himself was influenced by Master Jigoro Kano.

At the end of the 1960's Hiroo Mochizuki discovered the principle of wave motion and its increase of the physical power, optimized and multiplied at the point of impact. This was the starting point of the Development of YOSEIKAN BUDO (*). Hiroo Mochizuki is the inventor and founder of the Yoseikan Budo.

The wave motion is generated by two opposite, non-synchronous Forces. The change in frequency (timing) produces different amplitudes:

- short wave movement (for example for Atemi)
- medium wave motion (for example for weapons techniques with sword or Tonfa)
- long wave motion (for example for throws, naginata or lance)

The discovery of a common denominator to all disciplines – just like a tree produces all the branches - forms the basis of this modern method that is constantly evolving.

Designed as a place of constant search, the Yoseikan Budo is imperatively based on the compliance with anatomical and biomechanical principles as well as the balance of exercises involving both halves of the brain.

The infinitely wide field of application, such as practicing with bare hands or with weapons, in different distances, while standing or on the ground, helps the disciple to increase their ingenuity and ability to adapt. This extends their way of thinking.

With the help of the wealth of techniques the attitude of sharing, of mutual help and respect towards each other will be enhanced.

2. Name

Article 1

The "World Yoseikan Federation", WYF, is an association within the scope of Article 60 et seq Swiss civil code (ZGB) with seat at the place of residence of a Swiss Member of the Executive Committee or at the place of residence of one of the General Assembly appointed Swiss Yoseikan Budoka. The business year lasts from 1 January to

December 31. Article 2

The WYF is politically and denominationally neutral. It complies with the medical and Anti-doping guidelines of the Olympic Charter.

3. Goal

Article 3

The ultimate goal of the WYF is the support, the preservation, the dissemination and the development of Yoseikan Budo.

Article 4

Yoseikan Budo is the name of the martial art that was invented and founded between 1965 and 1970 by master Hiroo Mochizuki, born on March 21, 1936 in Shizuoka, Japan, and that he has since evolved.

Article 5

The goals in detail are:

- The promotion of Yoseikan Budo in all areas
- Protection of the Yoseikan Budo signet
- State recognition
- Hub of Yoseikan Budo between clubs, regions, countries and continents.
- Administrative and technical support for clubs, regions, countries and continents.
- Awarding and recognition of all international degrees, diplomas and Honorary diplomas. • Assigning of the World Championships
- Assigning of international courses Article 6

In order to achieve these goals, the EC is using working committees (commissions). For example the sports committee, advisers, ambassadors etc.



4. Finance

Article 7

The finances of the WYF consist of the annual contributions of the members, the contributions of the sponsors and the advertising revenues. The general assembly decides on the annual contributions of the members.

5. Members

Article 8

The members of the WYF are:

- National organizations, associations = normal case
- Continental associations = normal case
- Individual clubs on the condition that there is no national association in their country = exception
- Individual regions on the condition that there is no national association in their country = exception

One national organization per country is recognized.

Any national organization wishing to become a member of the WYF will write a written application to the CEO of the WYF.

6. Organs

Article 9

The organs of the WYF are:

6.1 The General Assembly, GA

6.2 The Executive Committee, EC

6.3 The Sports Commission, SC

6.4 The Auditors

6.5 Honorary President / Honorary Members 6.6 The Extraordinary General Assembly, EGA

6.1 The General Assembly

Article 10

The General Assembly (GA) is the supreme authority of the WYF. In this sense it decides on the course of business (the big strategic and financial decision) of the WYF and is executed by the EC. The GA grants discharge to all other organs of the WYF. The EC calls the GA.

Article 11

The invitation to the GA including agenda items must be sent to the members four weeks in advance.

Article 12

The requests of members must be submitted in writing to the President two weeks before the GA. Any deviating applications will not be dealt with at the GA.



Article 13

The GA elects the EC and the auditors every four years and, on the proposal of the EC, confirms the Sports Commission, i.e. the heads of the departments, the honorary president and the honorary members.

Article 14

The natural persons present, who have a member organization, a member state, representing the WYF and whose organization has paid their annual subscription before the day of the GA, have a voting right. The members of the EC and the presidents of the Continental Federations have one vote each at the GA. Each person present has at most one vote at the GA. The accumulation of votes is not allowed.

Article 15

The simple majority of the votes decides. In the case of equality of votes, the EC decides after consultation and the President announces the decision.

Article 16

The GA issues the statutes.

6.2 The Executive Committee

Article 17

The Executive Committee (EC) manages the business of the WYF in the sense of the GA. It proposes the sports commission, the honorary president and the honorary members to the GA.

Article 18

The EC distributes its roles (functions, tasks) independently. The EC consists of at least three persons. The decisions of the EC are subject to the simple majority. If there is equality of votes, the president's vote counts twice.

Article 19

The EK fulfills at least the following functions:

- Honorary President
- President, sets the strategy
- Vice-President, at least one, maximum of three persons
- Chief executive officer (PDG / CEO), is the operational director • Cashier

- Secretary

Article 20

Upon request, the heads of the sports commission can attend the EC without voting rights.



Article 21

A person of the EC can have several functions. The EC prepares a specification sheet for each function.

Article 22

The individual signatures of the president or CEO bind the WYF. The President can cancel the signature of the CEO in any case.

Article 23

The EC decides on the financial policy of the WYF.

Article 24

The EC decides on the admission, the exclusion and the sanctions against its members. Article 25

The EC approves the regulations and manuals of the WYF. These will be validated with the signature of the President. Innovations will come into effect at the beginning of each year (beginning of the WYF fiscal year).

Article 26

The EC proposes to the GA the appointment of the honorary members and the honorary president. The Honorary President is a member of the EC and has a vote in the EC and the GA as well as the right of veto. The EC can ask the honorary members for advice. The honorary members have no voting rights in the EC and at the GA.

6.3 The Sports Commission

Article 27

The Sports Commission (SC) consists of the heads of the departments and the members of the various departments. The SC receives its instructions from the EC.

Article 28

The SC organizes its departments independently. The SC prepares a specification sheet for each department. The SC draws up the regulations and manuals (detailed explanations of the processes) and submits them to the EC for coming into effect (homologation).

Article 29

The SK comprises the following three departments:

- Department SPORT: competition, refereeing and homologation of competition equipment
- Department of PEDAGOGY: training of coaches and training of examiners
- Department of TECHNICS: technical Dan program, development of the YB

6.4 The Auditors

Article 30

The auditors check the bookkeeping and submit it to the GA for discharge.



6.5 Honorary President / Honorary Members

Article 31

On the proposal of the EC, the GA may appoint a honorary president and honorary members.

6.6 The Extraordinary General Assembly

Article 32

Upon written request to the President of one-fifth of the voting members of the last GA or at the request of the EC, an extraordinary EGA will be convened.

Article 33

The EGA runs under the same conditions as a regular GA.

7. Final provisions

Article 34

The official language of the WYF is given by the association seat, which is also place of jurisdiction.

Article 35

The financial obligations of the WYF extend solely to its capital.

Any personal liability of the persons mentioned under 6.2 and 6.3 who work for the WYF is excluded.

The WYF disclaims all liability in the event of accidents, material damage and any other liability arising from practicing the Yoseikan Budo during WYF events.

Article 36

The place of jurisdiction is in Switzerland. Article 37

The WYF is dissolved when four-fifths of the voters of the last GA request it at a GA or EGA in writing to the President or when no EC can be determined anymore or when the WYF can no longer meet its financial obligations. See Articles 62 ff., Especially 76 and 77 of the Civil Code.

Article 38

These statutes replace all previous ones.
